

#### Purpose of this document

This document provides an implementation progress update for the 62 countries for which SOFF Readiness funding has been programmed, 60 of which Readiness funding was approved in 2023, and the 11 countries for which SOFF Investment phase funding was approved in November 2023 and March 2024.

The update highlights significant progress in Readiness phase implementation. 19 countries have fully completed the Readiness phase, 6 countries are close to completion, and 25 additional countries have submitted at least one output. In total 104 Readiness phase outputs have been delivered, i.e., almost 60% of all Readiness phase outputs.

Countries have started submission of their Readiness phase semi-annual progress reports highlighting the necessity for flexibility in completion time due to diverse country contexts.

The SOFF UNMPTF Gateway Platform is operational since in February 2024 and serves as the foundational tool for Investment phase implementation progress tracking and reporting for all SOFF Investment funding operations.

The document also provides a progress update of the 11 countries that have moved to the SOFF Investment phase and started implementation. A status update and brief narrative overview highlight the start-up progress of SOFF investments.

## **SOFF Implementation Progress**

### 1. SOFF portfolio

The SOFF portfolio of programmed countries currently includes 62 countries. These countries were programmed since November 2022 through three decisions made by the SOFF Steering Committee (<u>Decision 3.4</u>, <u>Decision 4.4</u>, and <u>Decision 5.4</u>).

#### 1.1. Readiness phase

60 of the 62 countries have received Readiness funding since March 2023 (<u>Decisions 4.3</u>, <u>Decision 5.3</u>, <u>Intersessional Decision 1.1</u>, and <u>Decision 6.2</u>). Two programmed countries yet to receive SOFF Readiness funding include Sudan and Guatemala. Currently in Sudan, all SOFF-related activities are on hold while Guatemala is delayed in submitting its Readiness funding request.

### 2. Readiness phase progress overview

Since April 2023, nearly 60% of the outputs have been submitted, marking the one-year milestone in SOFF implementation. 60 beneficiary countries, together with 20 active peer advisors, 7 Implementing Entities have prepared over 100 Readiness outputs<sup>1</sup> which have been screened by the WMO Technical Authority.

Out of the 60 countries included in the first, second and third programming batches, 19 have completed the Readiness phase, 6 countries are close to completing, and 25 additional countries have submitted at least one output. One country (Haiti), with Readiness funding approved in November 2023 (Decision 6.2), will start implementation in June 2024. Eleven countries have already moved to Investment phase (Decision 6.3) and 7 more have submitted Investment funding requests for consideration at the 8<sup>th</sup> Steering Committee meeting (INF 8.3 and Decision 8.4).

As per the assignment agreements with the Peer Advisors, countries have started reporting their semi-annual progress against the deadlines in the agreements. Factors such as organizational delays, complex country geography, challenges in liaising with the partners for certain beneficiary countries and overall capacity constraints were reported as causes of delays. Consequently, the initial timeframe was deemed insufficient to complete all the Readiness outputs and extension of delivery period was requested by several of them.

The SOFF Secretariat and WMO Technical Authority held webinars for knowledge sharing, lessons learnt and provision of technical support to the Peer Advisors on different topics such as GBON National Contribution Plan and WMO Information System (WIS 2.0) implementation during SOFF investment phase. For Country Hydromet Diagnostic (CHD)

a community of practice was formed by the WMO Technical Authority for peer advisors to share lessons on the CHD and SOFF engagement.

Ensuring flexibility in the implementation process is crucial for successful completion of the Readiness phase and smooth transition to the Investment phase. The SOFF Secretariat monitors the implementation of activities using an output-based approach and regularly communicates and assists countries and peer advisors as needed.

Annex 1: SOFF implementation portfolio provides an overview of the portfolio of the 60 countries currently implementing the SOFF Readiness phase.

The following sections break down SOFF Readiness implementation progress by batches of Steering Committee approval.

#### 2.1. First Batch

The first batch of 26 countries approved for Readiness funding started the implementation of Readiness activities in April 2023. 16 peer advisors and 7 Implementing Entities are engaged in the implementation of the Readiness activities in these countries. The figure below provides an aggregated overview of progress.




Figure 1. Progress of SOFF first batch countries. NGA – National Gap Analysis; NCP – National Contribution Plan; CHD – Country Hydromet Diagnostics.

All 26 countries in the first batch have submitted at least one Readiness output. Among them, 11 countries have already moved to the Investment phase and an additional 5 countries have submitted Investment phase funding requests for consideration by the 8<sup>th</sup> Steering Committee meeting. Additionally, 2 countries<sup>2</sup> have completed Readiness phase while 3 countries<sup>3</sup> are close to completing.

Readiness activities in the Democratic Republic of Congo began in December 2023. All outputs are on track for delivery, but the peer advisor foresees potential delays due to the complex geopolitical situation in the country.

While significant progress has been made, a few countries continued to experience delays due to administrative issues causing delays in country missions and activities, including challenges from difficult political situations, which have prompted requests for delivery period extensions.

Burkina Faso and Grenada have renewed their peer advisor assignment agreements, while Guinea-Bissau and Guyana have submitted amendments for an extension. Readiness activities in the Democratic Republic of Congo only began in December 2023. Although all outputs are currently on track for delivery, the peer advisor has reported potential delays due to the complex geopolitical situation in the country.

The table below presents the status of the delivery of the Readiness outputs for each country in the first batch.

#### 2.2. Second Batch




Figure 2. Progress of SOFF second batch countries. NGA – National Gap Analysis; NCP – National Contribution Plan; CHD – Country Hydromet Diagnostics.

The 10 countries approved in the second batch started implementation in July 2023 with the support of 7 peer advisors and 5 Implementing Entities. 2<sup>5</sup> countries are submitting Investment funding requests for consideration at the 8<sup>th</sup> Steering Committee meeting. Additionally, 2<sup>6</sup> countries are close to completing the readiness phase. Figure 2 presents the overview of the second batch progress.

Peer advisors have requested extension of delivery period to accommodate the delays stemming from circumstances akin to those encountered during the first batch.

#### 2.3. Third Batch

23 countries in the third batch of Readiness funding requests were approved through inter-sessional Steering Committee decision in September 2023 (Intersessional Decision 1.1) while Haiti funding was approved in November 2023 (Decision 6.2).

A total of 11 peer advisors and 7 implementing entities are supporting these countries.




Figure 3. Progress of SOFF third batch countries. NGA – National Gap Analysis; NCP – National Contribution Plan; CHD – Country Hydromet Diagnostics.

### 3. Investment phase progress overview

The 6<sup>th</sup> and 7<sup>th</sup> Steering Committee meetings approved Investment phase funding for 11 countries. Investment funding requests from 7 additional countries are for consideration by the 8<sup>th</sup> Steering Committee (INF 8.3).

Of the 11 approved countries, 8 have already received their first tranche of Investment funding, while 3 countries are in the process of finalizing the project documents in the SOFF UNMPTF Gateway. Two countries with MDBs (IADB and AfDB) as implementing entities are pending initiation of this process until signature of the Framework Agreement with UNMPTF; see Decision 8.4 Table 5 below provides a status overview by approved Investment funding request.

The first 4 countries that received disbursements in March 2024 have already commenced SOFF activities in the countries. The progress for those 4 is as follows:

- Mozambique: WFP and Instituto Nacional de Meteorologia (INAM) held an annual planning workshop in Maputo to discuss links with SOFF investments and other INAM projects, including early warning and anticipatory actions for drought and cyclones. Five colleagues from the South African Weather Service (SOFF peer advisor) were in Maputo to work with 17 colleagues from INAM and 5 colleagues from WFP on the annual planning exercise for SOFF activities, including consultation exercises (dates, participants, methodology, etc.), site assessment and procurement planning for land-based and upper air stations. SAWS provided training to INAM on GBON compliance as well as human capacity requirements for the roll out of SOFF activities. WFP and INAM are set to sign the MoU which includes SOFF activities in June 2024.
- Rwanda: Stakeholder engagement field trip was conducted to identify suitable site for an upper air/radiosonde. The draft of technical specifications for radiosonde was completed and shared to the peer advisor for review. In addition, a multi-year work plan was completed.
- Kiribati: Implementation modalities have been presented to and discussed with Kiribati Meteorological Service (KMS). Budget allocation between KMS and technical partners (such as New Zealand's National Institute of Water and Atmospheric Research – NIWA) is currently being discussed. The draft Legal agreement is being reviewed by KMS.
- Maldives: Implementation modalities have been discussed and agreed upon by Maldives Meteorological Service (MMS). Budget allocation between Maldives Meteorological Service (MMS) and Regional Integrated Multi-Hazard Early Warning System for Africa and Asia (RIMES) as a technical partner has been agreed upon and finalized. Legal agreements with both MMS and RIMES are being prepared and are under review, after which funds will be transferred from UNEP to these partners.



## 4. Regional workshops

The Intersessional Steering Committee meeting in January 2024 approved the SOFF Regional Workshops (Intersessional Decision 2.1) with the aim to foster regionally coordinated SOFF implementation, leveraging investments and climate finance opportunities beyond SOFF, and knowledge sharing and consultation on technical issues relevant to the respective regions.

So far, two workshops, namely SOFF Atlantic SIDS Workshop and SOFF Pacific Workshop have been held and two workshops are planned later this year.
