#### Purpose of this Document

This document presents an overview of the SOFF portfolio and its implementation progress. It builds on and complements the <u>SOFF dashboard</u> on the SOFF website.

It showcases the growth of SOFF portfolio since the first programming decision in November 2022 and includes a breakdown of the countries by regions and country groupings, including Small Island Developing States (SIDS), Least Developed Countries (LDCs) and Fragile and Conflict-Affected States (FCS).

SOFF has been delivering at speed and scale. Since the first programming decision in November 2022, 66 countries have been programmed to receive SOFF readiness support. Of the 60 countries with approved Readiness funding, 23 have completed the Readiness phase of which 13 countries have Investment phase funding requests approved. Additionally, five countries have received conditional approval for Investment funding, bringing the total approved budget to USD 115 million for Readiness and Investment support in less than two years of SOFF operations.

## SOFF Portfolio and Implementation Progress

## 1. SOFF operations overview

Since November 2022, 66 countries have been programmed to receive SOFF support (see full details in Annex 1). Out of these 66, Readiness funding has been approved for 60 countries following <u>Decision 4.3</u>, <u>Decision 5.3</u>, <u>Intersessional Decision 1.1</u>, and <u>Decision 6.2</u>, while six<sup>1</sup> programmed countries have not yet accessed Readiness funding.

Investment funding has been approved for 13 countries (<u>Decision 6.3</u>, <u>Decision 7.6</u>, <u>Decision 8.4.1</u>), amounting to a total of USD 80 million. An additional five countries have received conditional approval of Investment funding, pending availability of additional funding in the SOFF trust fund, totalling USD 26 million. Overall, USD 115 million has been approved or conditionally approved in Readiness and Investment support within less than two years of operations.



Figure 1. Overview of the evolution of the SOFF portfolio since the November 2022 Steering Committee. The number of countries at each phase are represented by bars according to the legend (right) and the amount approved in USD displayed in text.

The sections to follow present a breakdown of the SOFF portfolio (by region and country groups, including Small Island Developing States (SIDS), Least Developed Countries (LDCs), countries that are both SIDS and LDCs, and Fragile and Conflict-Affected States (FCS)) and report on the progress of implementation during the Readiness and Investment phases, respectively.

The enhanced <u>SOFF dashboard</u> complements this report and provides more granular information.

## 2. SOFF Readiness phase

#### 2.1. Portfolio




Figure 2: Regional distribution of countries receiving Readiness support.

The following figures provide an overview of the breakdown of SOFF Readiness phase implementation. Figure 2 highlights the regional breakdown of the 60 countries currently in the Readiness phase.




Figure 3. SOFF Readiness coverage for SIDS and LDCs, SIDS, and LDCs.<sup>3</sup>




Figure 4. SOFF Readiness coverage for fragile and conflict affected states.

Figures 3 and 4 demonstrate the Readiness portfolio broken down by countries classified as SIDS, LDCs, SIDS and LDCs and FCS. For each grouping, the percentage of the portfolio, the total number of countries<sup>2</sup> and the allocated budget are presented. ### 2.2. Implementation progress

Since the approval of the first batch of Readiness funding requests in March 2022, 23 countries have completed the Readiness phase. Overall, 75% of the total Readiness outputs<sup>4</sup> have been submitted by the 60 countries. These submissions are currently undergoing the screening process involving several iterations between the partners and the WMO technical authority – which has extended the timeline for their final completion, as explained below. The 60 countries are supported by 20 peer advisors and seven Implementing Entities (IEs). Details are outlined in Annex 2.




Figure 5. Readiness phase implementation progress.

Due to diverse contexts navigated during the Readiness phase, some countries have requested an extension beyond the initial six-month timeframe to complete the Readiness phase. Semi-annual progress reports from the countries cite several causes for delays including, organizational challenges, complex geographical conditions, difficulties in coordinating with partners in certain countries and overall capacity

constraints. However, all countries with approved Readiness funding are progressing towards completing the Readiness phase.

In the Caribbean, the region is planning to implement a regional GBON network, particularly for upper air stations, to enhance observational coverage and data collection. Finalization of Readiness outputs is pending the development of this plan. Technical support has been provided by WMO Technical Authority including through 2 webinars<sup>5</sup> for peer advisors, with an additional 2 planned<sup>6</sup>.

While the three Readiness outputs primarily inform the Investment phase, they also serve as a baseline for Early Warnings for All partners on GBON and hydromet capacities. Furthermore, these outputs offer a valuable resource for IEs and other partners, aiding in planning parallel investments aligned with SOFF activities.

Annex 2 provides a detailed overview about the Readiness phase implementation status.

### 3. SOFF Investment phase

#### 3.1. Portfolio

Countries classified as LDCs or SIDS which have completed the Readiness phase are eligible to receive support from SOFF during the Investment phase. The 8<sup>th</sup> Steering Committee meeting, held in June 2024, approved Investment phase funding for Chad (USD 7.0 million) and Uganda (USD 6.3 million), bringing the total number of countries with approved Investment funding requests to 13 and the total amount of approved investments to USD 80 million.

The Steering Committee also decided to conditionally approve USD 26 million for five additional countries subject to availability of financial resources and IEs' signature with the UN Multi-Partner Trust Fund Office (UNMPTF). <u>Decision 8.4.1</u> states that, once these conditions are met, disbursement of funding will be made to these countries in the following order: Madagascar (USD 4.4 million), Timor-Leste (USD 5.8 million), Samoa (USD 6.0 million), Nauru (USD 6.2 million) and Malawi (USD 3.9 million).




Figure 6. Regional distribution of countries receiving Investment support. Countries with conditionally approved Investment funding requests are represented in the lighter shade.

The regional distribution of the Investment phase funding requests is summarized in Figure 6 below.




Figure 7. SOFF Investment coverage for SIDS and LDCs, SIDS, and LDCs.8




Figure 8. SOFF Investment coverage for fragile and conflict affected states.

These countries have partnered with UN agencies and multilateral development banks to serve as IEs for the implementation of the Investment phase activities. See figure below for the distribution of IEs that are supporting the 18 countries with approved and conditionally approved Investment funding requests.




Figure 9. UN agencies and multilateral development banks serving as IEs for the Investment phase <sup>9</sup>.

Countries also work with peer advisors who provide on-demand advisory and technical assistance to implement Investment phase activities, such as supporting the development of tender documents; delivering trainings and technical workshops; and providing advice on data transfer, processing, and management. Currently, nine peer advisors are supporting countries in the Investment phase as shown in the figure below.




Figure 10. Countries with advanced National Meteorological and Hydrological Services (NMHS) serving as peer advisors for the Investment phase.

### 3.2. GBON gap coverage through SOFF Investments

The figures below illustrate the Global Basic Observing Network (GBON) gap covered through SOFF Investment fundings by region and country categories based on the WMO June 2023 Global Gap Analysis. The green sections represent the percentage of the total GBON gap that are covered through the 13 approved Investment funding requests, for each region or country category, while the orange sections indicate the remaining percentage of the gap that still needs to be addressed.




Figure 11. Percentage of GBON gap coverage by SOFF investment to date (green) and the remaining gap to be covered (orange) by country categories.






Figure 12. Percentage of GBON gap coverage by SOFF investments to date (green) and the remaining gap to be covered (orange) by region<sup>10</sup>.

#### 3.3. Implementation progress

#### 3.3.1 Status of disbursements




Figure 13. Status of Investment phase funding commitments for 18 countries (in USD, millions).

To date, first tranches for nine countries, namely Bhutan, Cabo Verde, Ethiopia, Kiribati, Maldives, Mozambique, Rwanda, Solomon Islands, and the United Republic of Tanzania amounting to a total of USD 46 million or 57 per cent of the approved Investment funding requests have been disbursed. First disbursements for Belize, Chad, South Sudan, and Uganda amounting to a total of USD 10 million, as shown in Figure 13, will take place once legal agreements are finalised and pending administrative requirements from the UNMPTF have been fulfilled.

Disbursements for the five countries with conditionally approved Investment funding requests will be processed following the procedure outlined in <u>Decision 8.4.1</u>.

#### 3.3.2 Implementation progress reporting

The SOFF Secretariat requested IEs supporting countries with Investment phase projects under implementation, namely Bhutan, Cabo Verde, Ethiopia, Kiribati, Maldives, Mozambique, Rwanda, Solomon Islands, and the United Republic of Tanzania, to submit their first progress updates covering the period from the approval of the Investment funding request until end of July 2024. These updates include information on the activities conducted following the approval of the funding requests and first disbursement as well as progress towards achieving the nine Investment phase outputs as summarized in Annex 4. On the other hand, IEs supporting Belize, Chad, South Sudan, and Uganda are expected to submit their first progress updates in January 2025.

While IEs did not raise any major risks or issues in the progress updates, the SOFF Secretariat takes note of the following during its review of the progress updates:

- Negotiation of legal agreements. IEs are required to enter into legal agreements with institutions that will serve as executing entities (EE). IEs have reported that finalisation of legal agreements required at least three months, hence such should be taken into consideration in developing the project implementation timeline.
- National elections and additional requirements from governments.
  Restrictions might be put in place by the government during the period of national
  elections. This includes restrictions on travel which would prevent IEs from
  conducting site assessments and thereafter delay the implementation of the
  project. Government agencies may also require IEs to comply with policies and
  submit additional requirements before project implementation can be allowed.
- Inception workshops and official project launches. Project launches have taken place or are planned for all Investment phase projects under implementation. These provide platforms for partners and stakeholders to convene and ensure alignment of objectives. In several cases, these launches have



been coordinated with EW4All or other high-level launch events such as that of in Mozambique and Rwanda.

### 3.3.3 Country updates

Narrative summaries of the progress updates submitted by the IEs as well as updates received from countries including those from the <u>SOFF regional workshop in Africa</u> held in Abidjan, Côte d'Ivoire on 11-13 September 2024 are presented below:

#### 3.3.3.1 *Belize*

Implementation of Investment activities is yet to start as the legal agreement between the IADB and the UNMPTF is pending.

#### 3.3.3.2 Bhutan

UNEP has focused during the first three months of implementation on engaging with the Government of Bhutan in finalizing the legal agreement that will formalize the Ministry of Finance as the EE for the project. A preliminary workplan and budget have also been developed in coordination with the National Centre for Hydrology and Meteorology.

The project is targeted to be officially launched at the <u>SOFF regional workshop in South Asia</u>, which will be held in Thimphu, Bhutan from 24 - 26 September 2024.

#### 3.3.3.3 Cabo Verde

UNEP reported that a legal agreement to establish the National Institute of Meteorology and Geophysics of the Republic of Cabo Verde as EE is being finalized and that a preliminary workplan and budget have been developed. It has also started working with technical partners that will support in implementing the activities such as the University of Twente and the Portuguese Institute for Sea and Atmosphere.

Following the effectiveness of the legal agreement with the EE and establishment of a project management unit, the project will be officially launched in the fourth quarter of 2024.

#### 3.3.3.4 Chad

Implementation of Investment activities is foreseen to start in the fourth quarter of 2024 once the pending administrative requirements from the UNNMPTF have been fulfilled.

#### 3.3.3.5 *Ethiopia*

Two months into implementation, UNDP has prepared the annual workplan and signed with the Ethiopian Meteorology Institute and the Ministry of Finance of the Government of Ethiopia a letter of agreement.

An inception workshop and project kick off is planned to be conducted in September 2024.



#### 3.3.3.6 *Kiribati*

Since the start of implementation in March 2024, UNEP has engaged with the Kiribati Meteorological Service in finalizing the legal agreement and in developing a preliminary workplan and budget.

The official project launch is planned to take place during the fourth quarter of 2024.

#### 3.3.3.7 *Maldives*

The legal agreement establishing the Maldives Meteorological Service as EE is now with the Ministry of Climate Change, Environment, and Energy of the Government of Maldives for countersignature. Engagements between UNDP and technical partners have also commenced including with the Regional Integrated Multi-Hazard Early Warning System for Africa and Asia.

The official project launch is planned to take place during the fourth quarter of 2024.

#### 3.3.3.8 *Mozambique*

WFP reported that a memorandum of understanding with Mozambique's National Meteorology Institute was signed in July 2024. A ministerial-level launch ceremony attended by the President of Mozambique, His Excellency Filipe Jacinto Nyusi, was held in May 2024. The event aligned with the launch of the national roadmap to achieve Early Warnings for All. For details of this event, please see Mozambique takes strides towards Early Warnings for All.

A timeline for the assessment of existing land-based stations and installation new land-based stations has been prepared while assessments and development of timeline for upper air stations are ongoing. The IE noted that the national elections in October 2024 might have implications on the ongoing work, particularly due to travel restrictions that might be imposed by the government.

#### 3.3.3.9 Rwanda

Coinciding with the celebrations for World Environment Day, a high-level event was held in June 2024 by the Government of Rwanda to introduce the project to the public. For details of this event, please see <a href="Rwanda launched SOFF Investment phase">Rwanda launched SOFF Investment phase</a>.

UNDP has worked with the Rwanda Meteorological Agency and other technical partners in identifying a site for the installation of an upper-air station and in identifying three land-based stations that are set to be upgraded. Following this, UNDP noted that the project has advanced to the procurement stage.



#### 3.3.3.10 Solomon Islands

UNDP noted in its report that the implementation and procurement plans for the project are currently being developed and that the process for recruiting the project management team is ongoing.

Following receiving endorsement from the Local Project Steering Committee in August 2024, an official project launch is expected to take place in the fourth quarter of 2024.

#### 3.3.3.11 *South Sudan*

Implementation of Investment activities is yet to start as the legal agreement between the AfDB and the UNMPTF is pending.

### 3.3.3.12 United Republic of Tanzania

Since the start of implementation in July 2024, engagements have taken p23e among UNDP, the Project Technical Coordination Committee, and the Tanzania Meteorological Authority. UNDP reported that an annual workplan has been developed and the project's governing bodies have been established. It also developed a communications plan to enhance the visibility of the project and its achievements.

Technical specifications of the meteorological equipment that need to be procured were prepared and designs for the buildings that will house the upper air stations have been developed. These have been shared with the peer advisor from the Danish Meteorological Institute for review prior to the launch of the procurement process.

The project has also been registered in the National Project Management Information System, which is a requirement by the government in order to proceed with the project launch which is planned to take place in October 2024.

### 3.3.3.13 *Uganda*

While there are still pending administrative requirements from the UNMPTF that are yet to be fulfilled before implementation officially starts, the country reported that the procurement plan and strategy are now under development and the establishment of a project management unit is underway.
